Faculty acknowledges and supports the request regarding the process and timeline for feedback on the Strategic Plan draft. Specifically, Senate recommends that:

1. The Strategic Planning Steering Committee commits to a response to LRAP feedback.
2. LRAP be given the opportunity to provide feedback on the response.
3. The deadline for initial feedback on the provided Strategic Plan draft be extended to allow the above.
4. LRAP make reasonable efforts to keep the planned Strategic Plan release date of May 1, 2026, which is the revised timeline as communicated by President Lepre to the Faculty Senate President on March 3, 2026.
5. Senate share a revised draft with all faculty for greater faculty review and feedback to LRAP, increasing potential buy-in overall.

JUSTIFICATION: Per Senate bylaws, "The Long-Range Academic Planning Committee exists to represent all academic and Faculty perspectives pertinent to the strategic planning processes of the University." LRAP has submitted a request for more participation in the Strategic Planning process.

ANTICIPATED IMPACT:
