- III. Staff Senate Reports
 - a. Staff Senate 2nd Chair – Candace

- VII. 11am - Special Guests
 - a. President's Office Report – Eric Stewart
 - i. Executive Order impact, working with AG's office to determine impact. Information coming out so frequently, websites have updated materials for each executive order.
 - 1. Not as directly impacted by federal funding issues, College Park and Hopkins have a larger impact. 800m in grants cut from Hopkins on Tuesday.
 - ii. Budget – Indirect impact from those cuts like at Hopkins affecting state overall which can have tax revenue impacts that trickle down. MD losing revenue puts USM under threat for additional cuts. The proposed budget that came out in January had a 5% cut to USM which translates to around 4m cut to SU.
 - iii. USM discussing lifting the tuition cap to provide more flexibility for schools in current budget climate.
 - iv. SU remains in a relatively good budget position, have a plan for the existing 5%/4.8mil budget cuts.
 - v. Middle states – onsite visit went well and is completed. 3+ year process between the reports, visiting teams etc. Zero recommendations/findings from the team. Last cycle we had two recommendations regarding strategic planning alignment. Middle states have 3 tiers of results, requirements, recommendations and collegial advice.
 - 1. Highlighted our commitment to improve campus climate around DEI
 - 2. Praised us for being transparent in communications, especially with students.
 - 3. Two Collegial Advice Notes –
 - a. Need to align faculty staffing levels with enrollment, need to raise student to faculty ratio. To stay fiscally viable, need to get closer to 18:1
 - b. We should be more adventurous in exploring AI
 - vi. Legislative Session – Has been good about not introducing unfunded mandates/requirements this session.
 - vii. Strategic Planning Updates – Steering committee is hosting sessions with faculty/staff/students
