The Guerrieri Academic Commons will be open on a different schedule than last year. Given the low use after 2 a.m.—see the chart below—and other security needs across campus, there will be no space open 24/5. We will, however, be open 24/7 during the last week of classes and final exam week. And, in case you were wondering, we are open the second-most hours of any public university library in Maryland.
